From Northeast:

Wadhams Rd south, about 7 ½ Mi. past Gratiot, slight right onto Indian Trail, about 1 ½ Mi. to Meisner Rd, right (W) about 1 Mi. to barn, turn right.

OR: I-94 westbound to Wadhams Rd exit Turn left (S) onto Wadhams Rd, about 6 Mi., slight right onto Indian Trail, about 1 ½ Mi. to Meisner Rd, right (W) about 1 Mi. to barn, turn right.

From Southwest:

I-94 eastbound to 26 Mi. (Marine City Hwy), right (E) about 6 Mi. to Palms Rd, left (N) about 2 Mi. to Meisner, right (E) about 3 Mi. to barn, turn left.

From North of Richmond:

M-19 south to Division (Fred Moore)-in downtown Richmond, left (E) about 6 Mi. to Palms Rd, right (S) about 4 Mi. to Meisner, left (E) about 3 Mi. to barn, turn left.

If Division is still closed in town: continue on M-19 through town, near Kmart, left on Muttonville Ln, left on Gratiot about 1 ¼ Mi. to Division (Fred Moore), right (E) about 4 ½ Mi. to Palms Rd., right (S) about 4 Mi. to Meisner, left (E) about 3 Mi. to barn, turn left.

From Goodells Park:

Turn left on County Park Rd., left on Goodells Rd., about 1 Mi. to Sparling Rd. right about 1 Mi. to Wales Center Rd., left about 5 ½ Mi. to Rattle Run Rd left about 2 Mi. to Palms Rd., right (S) about 8 ½ Mi. to Meisner Rd., left (E) about 3 Mi. to barn, turn left.
