FROM THE BOARD- The meeting was called to order at 6:59 pm on May 5th, 2011. Officers present were Sue, Terri, Heather and Marianne, and Shauna. Diane was a little late. Denise sent Tiffany in her place. Guests present were Ingrid Cieplechowicz, Hannah Cieplechowicz, Tiffany Schultz, Holly Cuthbertson and Karen Pidick. Minutes were read from the previous meeting. No corrections were made. Motion to accept the minutes was made by Terri and seconded by Marianne. Motion passed. The treasurer's report was explained. No corrections were made. Heather turned in \$30 from a sponsorship. Sue turned in the 272.85 from the bake sale (\$50 was the starter fund). Motion to accept the treasurer's report was made by Heather and seconded by Terri. Motion passed.

Committees: Show Secretary- Holly has one entry for the first show. Brylin contacted her to say she has the days off for our shows. ACS- We have some answers from AHA. There was miscommunication between AHA and us.

They were never going to give points to only horses. To have points count you must be a valid, current member of the AHA. There will be no point changes to prior years.

Banquet- Becky will contact Achatz to see what the prices would be for a spaghetti dinner. Fundraising- There is no word on the raffle yet. There was a profit of \$222.85 from the bake sale. We are looking into having two locations next year. We also need to look into a way to keep the bake goods from melting in the sun.

Judges- Sue has the contracts from three judges but is still waiting for the last one. Sponsorship- We received one new sponsorship in the mail. We now have 19 members and 5 sponsorships.

Scholarship- Sue has one scholarship turned in and thinks we could have up to 5 applicants this year. Applications are due to Sue by June 1st. New Business- Terri made a motion that we eliminate the November and January meetings each year. Shauna seconded and the motion passed. This will be changed in the by-laws in October.

Motion to adjourn the meeting was made by Terri and seconded by Shauna. Motion Passed. Meeting adjourned at 8:09 pm.
