Criteria for Judging Applications

The scholarship committee has prescribed these criteria for judging all scholarship applications. The following headings should be weighted by the associated percentage:

- **Overall presentation** ----- 15%
 - a) Neatness 5%
 - b) Accuracy (spelling, grammar, etc) 5%
 - c) Following directions 5%
- **Academics** ----- 10%
- **Extracurricular Activities** ----- 10%
- **SCCAHA Involvement** ----- 25%
- **Interview** ----- 20%
- **Career Plans Essay** ----- 20%
